

TERMS AND CONDITIONS

INTRODUCTION

The Solomon R. Guggenheim Foundation (the “Foundation”) provides this Web site (the “Site”) in support of its charitable and educational mission to further the understanding and appreciation of art by the public. It supplements the outstanding art collections and educational programs we offer onsite at the Solomon R. Guggenheim Museum, the Guggenheim Museum Bilbao, the Peggy Guggenheim, the Deutsche Guggenheim, the Guggenheim Hermitage Museum, and through related alliances around the world. We encourage you to use the Site as a research and information tool, subject to the specific terms and conditions of use (the “Terms and Conditions of Use”) set forth here.

ACCEPTANCE OF TERMS AND CONDITIONS

BY ACCESSING THIS WEB SITE, YOU ACCEPT WITHOUT LIMITATION OR QUALIFICATION THESE TERMS AND CONDITIONS OF USE. THE FOUNDATION MAY REVISE THESE TERMS AND CONDITIONS OF USE AT ANY TIME, BY WHICH REVISIONS SHALL BIND YOU. IF YOU DO NOT WISH TO BE BOUND BY THESE TERMS AND CONDITIONS, PLEASE EXIT THE SITE NOW AND REFRAIN FROM FURTHER USE.
